### New air service for Pendleton

Third level air carrier service returns to Pendleton July 14.

Don Pentico, president of Intermountain West Airlines, with headquarters in Fresno, Calif., announced Wednesday that nonstop service between Pendleton and Portland would be started on a basis of two flights a day in each direction. Pentico said they had surveyed the needs and desires of the flying public and tried to schedule the flights accordingly.

Non-stop service to Portland will leave Pendleton at 9:20 a.m. and again in the exening at 7:15. Service will leave Portland for Pendleton at 8:05 a.m. and at 6:00 p.m. Flying time is scheduled at 55 minutes for all flights and they will operate in and out of the Portland International Airport, Fore will be \$25 one way and \$44 round-trip.

#### \$250,000 LOSS WEDNESDAY WHEN FIRE DESTROYS ARROW CHEVROLET

Fire of major proportions struck the downtown area of Pendleton Wednesday night, completely destroying the Arrow Chevrolet Co, at 335 S.E. Court.

The fire began shortly before 10 o'clock and at its height was sending flames billowing 50 to 75 feet into the air. All available men and equipment were ordered to the scene and it was after midnight before the fire was brough under control. Several men remained on duty all night to patrol the fire and even at 6 Thursday morning were still extinguishing small spot fires that were popping up.

The fire apparently started on the east wall near an exit door and one observer said he saw wiring arcing just before the fire broke out. Destroyed were an estimated six new cars and at least 11 customer cars which were in for service.

The 100 by 150 foot building is owned by William Roesch of Pendleton who said it was valued at approximately \$100,-000. He said it was covered by insurance.

Arrow Chevrolet Co. is a subsidiary of a Boise operation

which had only recently purchased the auto firm from Mr. and Mrs. Jack Clubb of Pendleton, Jason Smith, the manager, and his staff were busy during the height of the fire finding keys and moving over 20 brand new cars parked on a lot adiacent to the burning building. There has been no estimate placed on the amount of loss to the contents but an early figure (Continued on Page 8)
